**RESOLUTION ESTABLISHING A STANDARD WORK DAY
FOR ELECTED AND APPOINTED OFFICIALS
PARTICIPATING IN THE RETIREMENT SYSTEM OF THE STATE OF NEW YORK**

WHEREAS, Regulation 315.4 of the Office of the New York State Comptroller requires all municipalities to make a reporting of a Standard Work Day and Reporting Resolution for all elected or appointed employees who participate in the New York State Retirement System; and

WHEREAS, annexed herewith is the completed RS 2417-A form provided by the New York State Comptroller’s Office setting forth the standard workday for the applicable employees of the City of Gloversville.

NOW, THEREFORE, it is hereby

RESOLVED, that the City of Gloversville adopts the standard work day for elected and appointed officials participating in the New York State Retirement System; and it is further

RESOLVED, that the Gloversville City Clerk is directed to post the instant Resolution together with completed form RS 2417-A on the official website of the City of Gloversville for a minimum period of thirty days and is further directed to file a certified copy of instant Resolution together with an affidavit of posting with the Office of the State Comptroller within 45 days of the adoption of the instant Resolution.
